**Sub:- Tentative Seniority list of Deputy Foresters of Jammu Region as it stood on 01-01-2021.**

### Notification

Whereas, the final seniority list of Deputy Foresters borne in the establishment of Jammu Region was issued vide this office Circular No. CCF-J/Estt/NG/1426-45 dated. 14-09-2018;

Whereas, some incumbents out of the final seniority list issued vide this office No. CCF-J/Estt/NG/1426-45 dated. 14-09-2018 have been promoted, retired and accordingly their names shall have to be deleted from seniority list;

Whereas, some Forest Guards who have been promoted as Deputy Foresters and are to be included in the Seniority List of Deputy Foresters of Jammu Region;

In view of the above, it is necessitated for issuance of an updated tentative seniority list of Deputy Foresters deleting the names of those who have either retired from service or promoted to the next higher grade and adding those who have been promoted as Deputy Foresters as it stood on **01-01-2021** forming **Annexure "A"** to this Notification, is hereby issued for the information of all the concerned officials;

Any official having objections with regard to his placement in the tentative seniority list shall represent through proper channel alongwith relevant documents within a period of 21 days from the date of issuance of this notification failing which it shall be presumed that there is no objection from any official against his placement in the tentative seniority list and final seniority list will be issued accordingly.

The date of births recorded against the officials in the tentative seniority list shall not be taken as authentic and shall always be subject to verification from the service book/date of birth certificate.

The DDOs shall ensure that the seniority list is circulated among all the Deputy Foresters of Jammu Region, so that they are apprised about their seniority positions.

The seniority list shall however be subject to outcome of writ petition/s, if any pending before the Court/s of Law.
