
CAMPA ORDER NO. 01 OF 2021
D A T E D: 27.04.2021

Pursuant to the decision taken in the Steering Committee of CAMPA in its 19th meeting held on 26.02.2021 wherein it was directed that "the outlay proposed for Soil and Water Conservation Department in the APO for FY 2021-22 shall be allocated to the Territorial DFOs in order to ensure integration of the activities of both departments. Field functionaries of Soil and Water Conservation Department shall execute the proposed soil & moisture conservation works under the administrative and financial control of the DFO concerned".


2. In view of the decision taken by the Steering Committee, and in continuation to this office letter No.PCCF/CAMPA/2021-22/1199/158-216 dated 26.04.2021 (photocopy enclosed), it is hereby ordered that all DFOs on receipt of APOs for FY 2021-22 from the concerned DSCOs shall take administrative approval of the competent authority in the Forest Department, while technical sanction shall be issued by the competent authority in the Soil & Water Conservation Department. The tenders for such works shall be floated by the DFO concerned. The expenditure shall be booked by the DFOs only after issue of certificate of quality and quantity of work done by the DSCO concerned. CAMPA Secretariat shall allocate required funds for such works to the DFO concerned based on their requisition.

3. The DFOs and the controlling officers shall ensure that timelines as laid out for accord of AA/TS and E-tendering shall be adhered to in all cases.
