**Sub: Supplementary Annual Plan of Operation for the incomplete works under approved APOs of 2020-21 – regarding.**

Sir/Madam,

It has been reported by a few Implementing Agencies that some site specific works approved in the Annual Plan of Operation for the FY 2020-21 could not be completed by 31 March 2021 for various reasons. Besides, some bills in respect of executed works could not be cleared by the Treasury by 31 March 2021. Since approval for APO 2020-21 has expired on 31 March 2021, in both such cases, supplementary APO for FY 2021-22 has to be prepared along with justification and proof of the executed work.

2. Accordingly, it is requested to kindly advise the implementing agencies under your administrative control to prepare supplementary APO for the site- specific works of FY 2020-21 falling in above two categories for completion in the current FY 2021-22, and to submit the same to the CAMPA Secretariat by 30 April 2021. It must be ensured that while preparing the supplementary APO for FY 2021-22, no change in site and physical/ financial targets approved in the 18<sup>th</sup> meeting of Steering Committee is made. It must also be noted that supplementary APO for non-site specific proposal shall not be entertained.
