In pursuant to the Selection list issued by the J&K Services Selection Board vide letter no. SSB/Sel/Secy/2018/8836-43 dated: 24-07-2018 and order no. 67-SSB of 2019 dated: 06-03-2019 duly endorsed by the Administrative Department vide No. FST/Coord/105/2018 dated: 05-04-2019 and instructions issued by the Pr. Chief Conservator of Forests, J&K Government, Srinagar vide No. PCCF/NG/Estt/277/1638 dated: 16-05-2019, the following candidate falling in District Cadre Reasi is hereby temporally appointed as Forest Guard in the pay scale of Rs. 19900-63200+usual allowances purely under the provisions of SRO 202 of 2015 dt: 30-06-2015 and is directed to report to the Division shown against him for further duties.

However, the appointment of the above named candidate shall be subject to the fulfillment of the following conditions:-

- A. The above named appointee will submit joining report to DFO Reasi alongwith the following documents/certificates in original and self-attested photocopies of the same within a period of 21 days from the date of issue of this order:-
1. Date of Birth Certificate (Matriculation)
  2. Permanent Residence Certificate (PRC).
  3. Academic Qualification Certificate.
  4. Category Certificate issued in terms of SRO-294 of 2005 dated: 21-10-2005, if applicable;
  5. Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee;
  6. Certificate from the Deputy Director Employment concerned to the effect that the candidate is not employed in any Government Department or Semi-Government Organization.
  7. Physical Fitness Certificate from the concerned Chief Medical Officer;
- B. The appointee shall be on probation for a period of 05 years as provided in Rule-8 (1) & (2) of Jammu and Kashmir Special Recruitment Rules-2015 notified vide SRO-202 of 2015 dated: 30-06-2015;

- C. The appointment including Pay, service etc of the above appointee shall be governed in terms of Jammu and Kashmir Special Recruitment Rules-2015 notified vide SRO-202 of 2015 dated: 30-06-2015;
- D. The appointment in District Cadre is not transferable from one District to another and even cadre change is not acceptable;
- E. In case the above appointee fails to join in the Divisional Office, as mentioned above, and produce required documents/certificates in original and self-attested photocopies of the same within the prescribed period of 21 days from the date of issue this appointment order, it shall be presumed that the candidate is not interested in joining the Department and the order of appointment in respect of the defaulting candidate shall be cancelled ab-initio, without any further notice;
- F. It shall be the responsibility of the DDO to establish genuineness/validity of qualification and other certificates.
- G. The appointment shall also be governed as per provision of the SRO-335 of 1991 dated 28.11.1991 and his salary shall be drawn and disbursed by the DDO only after satisfactory character and antecedents certificates received from CID (J&K Police Deptt.)
- H. The appointment of the above candidates shall be subject to the outcome of writ petition(s) pending (if any) in any competent Court of Law, as provided in the selection list of the SSB.
