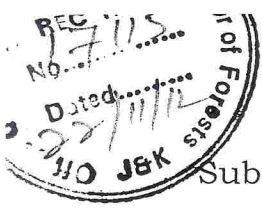

In terms of rule 3(iv) of SRO-103 of 2012, sanction is hereby accorded to the constitution of Broad Based Committees one each for Jammu and Kashmir province with the following composition:-

01	Chief Conservator of Forests Jammu.	Chairman
02	Director Industries & Commerce Jammu.	Member
03	Conservator of Forests East/West/ Chenab Circles of Jammu Division.	Member

The above Committees will address the issues pertaining to Saw Mills, Veneer & Plywood Industries and will also suggest restriction on the maximum number of primary and secondary wood based industries that may be installed in any given locality within a Territorial Forest Division considering the availability of raw material, existing capacity of Saw Mills etc. strictly under the provisions of Jammu and Kashmir Wood Based (Saw Mills, Veneer & Plywood) Industries (Registration & Regulation) Rules 2012 notified vide SRO-103 of 2012 dated: 26.03.2012.
