As recommended by the J&K Services Selection Board vide No. SSB/Sel/Secy/2017/7614-20 dated 28.8.2017, sanction is accorded to the temporary appointment of Shri Randeep Kotwal S/o Late Om Kumar Kotwal R/o Village Udrana Tehsil Bhadarwah District Doda (Open Merit) as Junior Assistants, in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs.1900 in the "Divisional Cadre Jammu" Forest Department under SRO 202 of 2015 dated 30.6.2015 with immediate effect.

The above appointees shall report to Chief Conservator Forests, Jammu within a period of 21 days from the date of issuance of this appointment order. In case of failure of any appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.

The appointee shall be allowed to join only on production of the following certificates in original;

1. Date of Birth Certificate (Matriculation)
2. Qualification Certificate;
3. Permanent Residence Certificate (PRC);
4. No Demand Certificate from concerned District Industries Centre;
5. No employment certificate from the Department of employment;
6. Physical Fitness Certificate from the concerned Chief Medical Officer;
7. No Demand Certificate from the Electric Department on account of Electric Fee;
8. Category Certificate issued in terms of SRO-294 of 2005 dated 21-10-2005, if applicable;
9. Character antecedents verification certificate of the CID Department.

The appointment of the above candidate as Junior Assistant shall further be subject to the following conditions;

- (i) Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from Inspector General of Police (CID) J&K to whom a reference shall be made by this office, the candidate shall have no right to claim his/her appointment as

- Junior Assistant and his appointment as such shall be deemed to have cancelled ab-intio.
- (ii) Verification/genuineness of the qualification certificates, reserved category certificate from the concerned issuing authorities.

The salary of appointee shall not be drawn and disbursed to him unless the satisfactory report in respect of (i) and (ii) above are received in his favour.

The appointees shall be on probation for a period of two years and shall undergo and qualify the Secretariat Assistant Examination (Foundation Course) during the period of probation.

The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009 and as per the provisions of SRO 202 of 2015 dated 30.6.2015.

The inter-se-seniority of the above appointee shall be on the basis of the merit secured by the said appointee as recommended by the J&K Services Selection Board.
