- b) Work component wise details of unspent money remitted into CAMPA account.
- c) Details of liabilities.
 - i) Work done/procurements made but payment could not be made/expenditure could not be booked till 31 March 2020.
 - ii) Tendered works which could not be completed due to COVID-19 pandemic.
- d) Physical/financial progress report ending March 2020 (for the full year).
- e) UC for the money spent during 2019-20.

It may please be noted that those implementing agencies which fail to furnish above documents/information by 18 May 2020 shall be considered ineligible for receiving funds under CAMPA in the current financial year.
