- a) The Regional Level Committee shall:
- i. Carry out comprehensive physical verification (quality and quantity) of works with reference to the approved Annual Works Programme executed under different schemes during the last three years viz. 2015-16, 2016-17 & 2017-18.
- ii. Submit its report within three months of the issue of this order.
- b) The State Level Committee shall:
- i) Carry out random physical verification of all works executed under different schemes during the last three years viz. 2015-16, 2016-17 & 2017-18.
- ii) Ensure that geo-coordinates (Polygons) of all works are uploaded in e-green watch portal of Government of India, Ministry of Environment, Forest and Climate Change.
- iii) Conduct financial audit of funds through the CAG empanelled Chartered Accountants.
- iv) Regularly review the progress of Regional Level Committee.
- v) Submit its report within a period of six months time from the date of issue of this order.
- c) The expenditure on account of Monitoring of Evaluation of all works shall be borne by the State CAMPA.
