Subject: Allotment of funds under Compensatory Afforestation Fund Management and Planning Authority (CAMPA).

Consequent upon the approval accorded by Steering Committee CAMPA in its 15<sup>th</sup> meeting held on 14.08.2018, sanction is hereby accorded to the release and placement of 1<sup>st</sup> installment of funds to the tune of Rs. 6.00 Crore (Rupees Six crore only) against the Approved APOs for the year 2018-19, from Compensatory Afforestation fund Management and Planning Authority (CAMPA) funds in favour of Pr. Chief Conservator of Forests(HoFF)/Chief Wildlife Warden, Wildlife Protection Department, J&K Srinagar.

However, the allotment of above amount is subject to fulfillment of following terms & conditions that:-

1. Instructions of the Govt. issued from time to time w.r.t. spending of public money should be followed strictly while making expenditure.
2. The funds released should be spent on approved items of sanctioned outlay and as per the approved tariff rates without creating any liability thereto and no re-appropriation or diversion of funds from one component to another or one object head to another is admissible without the approval of competent authority.
3. The execution of works shall be taken up only up to the availability of funds within the sanction/approved cost.
4. The rates charged are according to approved Tariff for various forestry operation and PWD schedules rates for the items not covered in the forest Tariff.
5. The works are executed under close supervision of competent staff.
6. The works should be completed within the stipulated time period.
7. The expenditure does not exceed the provisions approved for the work.
8. The photography of each work before, during and after its execution shall be done in order to maintain the documentation.
9. The Monthly Progress report should be submitted regularly by or before 5<sup>th</sup> of every month.
10. All codal formalities and procedures required under rules are fulfilled before execution of the work. The funds so allotted should not be construed as an authority to spend unless the provisions of extant rules and regulations are fulfilled.
