2. The J&K Govt. Gazette, 2nd March, 2014 (S. Chit. 1936) [P.M.3]

Be it enacted by the Jammu and Kashmir State Legislature in the Sixty fifth Year of the Republic of India as follows :—

1. *Name and commencement*.—(1) This Act may be called the Jammu and Kashmir Wildlife Protection (Amendment) Act, 2014.

(2) It shall come into force from the date of its publication in the Government Gazette.

2. *Substitution of Schedule-VI, Act No. VII of 1978*.—For Schedule-VI of the Jammu and Kashmir Wildlife (Protection) Act, 1978, the following schedule shall be substituted, namely :—


"SCHEDULE-VI"

1. "Beddome" cycad (*Cycas Beddomei*) ;
2. Blue Vanda (*Vanda Coerulea*) ;
3. Kintu (*Saussurea lecostus*) ;
4. Ladies slipper orchids (*Paphiopedilum spp.*) ;
5. Pitcher plant (*Nepenthes Khasiana*) ;
6. Red Panda (*Ailurus fulgens*)."
