1. The Bids shall be deposited in electronic format on the Departmental Website:- <https://jktenders.gov.in>.
2. The price bids uploaded on the website in time will be opened on **20.09.2016** at **12:30 PM** in the office of **(in the Office of Conservator of Forests, East Circle, Forest Complex, Dogra Hall Jammu)**. In case of public holiday on the date of opening of the bid, the same will be opened on the next working day at the same time and venue.
3. Bids must accompany cost of tender document as shown against each work in the shape of demand draft in favour of **Divisional Forest Officer, Billawar Forest Division, Billawar** and earnest money in shape of CDR/FDR pledge to **Divisional Forest Officer, Billawar Forest Division, Billawar**. The bids for the work shall remain valid for a period of **90 days** from the date of opening of bids.
4. In case the cost of lowest bidder is found below the advertised amount, the bidder has to deposit an additional security performance in the shape of CDR/FDR before issuance of award of contract to the tune as per below details:-
 - a. *Upto 10% below rate over advertised cost Nil*
 - b. *10% to 20% below rate over advertised cost 3% of advertised cost in shape of CDR/FDR.*
 - c. *20% to 30% below rate over advertised cost 5% of advertised cost in shape of CDR/FDR.*
 - d. *Upto 30% below rate over advertised cost 5% in shape of CDR/FDR of advertised cost & 5% in shape of bank guarantee of advertised cost.*
5. Bidders are advised to download bid submission manual from the “Downloads” options as well as from “Bidders Manual Kit” on website www.jktenders.gov.in
6. To participate in bidding process, bidders have to get Digital Signature Certificate(DSC) as per IT Act, bidders can get Digital Signature Certificate from approved vendor.
7. The Bidders have to submit their financial bids online in electronic format with digital signature. No financial bid will be accepted in physical /hard form.
8. Bids will be opened online as per time schedule mentioned above.
9. Bidders must ensure to upload scanned copies of all necessary documents i.e CDR,PAN,TIN, Demand Draft, Registration Card and hard copies of all these documents should also reach to the **office of Conservator of Forests, East Circle, Forest Complex, Dogra Hall Jammu** on **19.09.2016** upto **2:30 PM**. No registered post/courier will be accepted.
10. The Department will not be responsible for any delay in online submission of the bid due to any reason(Technical or otherwise).

11. The Department shall not be held responsible for selection criteria/policy matter being adopted by the Directorate of Information regarding publishing the e-NIT, in any of the newspaper under circulation.
12. The accepting department however reserves the right to reject any or all the tenders without assigning any reasons thereof.
13. The contractor shall arrange the key materials like Cement, Steel in his own from authorized dealers for the above said work and quality of material shall be ISI marked and have to be verified/passed by the concerned Asstt. Executive Engineer and Officers of the department before start of work.
 - a. Cement of Ambuja, ACC, Birlas Plus, JP Buland, Banguar or equivalent brand.
 - b. Steel of SAIL, TATA TISCON, Rashtriya Ispat or equivalent brand.
14. All other terms and conditions shall remain same as per PWD Form 25(double leaf) and as per the detailed document.
