Sub: Submission of Annual Plan of Operations for the FY 2021-22.

Sir/Madam,

The draft Annual Plan of Operations (APOs) for the FY 2021-22 have been discussed in two meetings held – in respect of IAs of Jammu Region on 25 November 2020 and in respect of IAs of Kashmir Region on 02 December 2020 – under the chairmanship of Pr. Chief Conservator of Forests & HoFF, J&K Forest Department. In accordance with the suggestions made during these meetings, the APOs need to be modified wherever required, and submitted to the CAMPA Secretariat latest by 10 December 2020 duly approved by the Head of Department/CCF concerned.

2. It must be ensured that the APOs are in accordance with the CAF Rules 2018 and guidelines given in the communications No. PCCF/ CAMPA/ APO-2021-22/1125/2732-97 dated 26.9.2020 and No. PCCF/ CAMPA/ APO-2021-22/ 1125/3060-62 dated 20.10.2020. While submitting the APOs, it may be certified that (i) site specific interventions are in accordance with prescriptions of the working plans (ii) proposed action plans have been formulated in consultation with Panchayat concerned and (iii) KMZ files have been properly checked.

3. Besides, inputs for the meeting of Executive Committee of CAMPA, as sought vide this office communication No. PCCF/ CAMPA/ APO-2021-22/1125/ 1196-1204 dated 04.11.2020, may also be submitted along with APOs.
