Sub: Preparation of Annual Plan of Operation (APOs) for the year 2020-21 under CAMPA in accordance with Central Compensatory Afforestation Fund (CAF) Rules, 2018.


Sir/Madam,

This is in continuation of this office communication No. PCCF / CAMPA/APOs/ 2019-20/ FNo.919 /9117-74 dated 25.09.2019 followed by reminder No. No. PCCF/ CAMPA/ FNo.919/ 5967-6032 dated 20.11.2019 regarding the above subject. The APOs for 2020-21 which were supposed to be submitted by 28 November 2019 have not yet been received by this office.

2. In this connection, I am once again directed to request you to furnish the APOs alongwith KMZ files, duly scrutinized and recommended by you latest by 3 December 2019 (evening) to enable this office to examine and place the same before the Executive Committee of CAMPA, which is scheduled to meet on 7 December 2019 in respect of Implementing Agencies of Jammu region and on 10 December 2019 in respect of Implementing Agencies of Kashmir region.

3. It may be ensured that the APOs are strictly in accordance with the Working Plan/ Management plan prescriptions and prepared in consultation with Panchayat or Village Forest Committee or whichever is applicable. It may also be ensured that prescribed activities of allied Departments in forest areas (particularly Social Forestry Department and Soil & Water Conservation Department) are integrated with activities of Territorial Divisions concerned, through Conservator of Forests Territorial. Besides, proposal for maintenance of plantations raised under CAMPA in last 3 years @ 25%, 15% & 5% of plants for 2nd, 3rd, & 4th year of plantations respectively, subject to actual requirement, be included in the APOs.
