
Sub: Assessment of utilization of funds against the approved APO of 2019-20.

Sir/Madam,

As implementation of the approved APOs of the current financial year has entered into 4th quarter, all Implementing Agencies are expected to have a clear assessment of likelihood of execution of all the activities approved in the current year's APOs and also of those activities in rare cases, which cannot be executed for genuine reasons in the current financial year.

- 2) In order to ensure that the approved amounts in the current year's APOs are fully utilized, all IAs are requested to intimate the activities which are not likely to be executed in the current financial year and the money which is likely to remain unspent. Further, they are requested to indicate the alternate similar activities for which the unspent money can be allocated for utilization in the current year.
- 3) All the IAs are requested to kindly provide the information urgently latest by 8th January 2020 by E-mail for placing the same before the Steering Committee of CAMPA for accord of approval.
