
Sir,





The joint nishandahi team reported that the said land where Mohd Yaqob Malik constructed shops falls in Khasra No.803/1 registered as **Shamalat Deh** where they possessed 10 marlas of land as per revenue record .(joint Nishandahi report enclosed)

Hence report submitted to your good self that as per report of Joint inspection team the said shops constructed by Mohammad Yaqoob Malik S/o Alif Din Malik R/O Chowkian Block Darhal was not constructed on Forest land please.


