

This office has received a complaint from Sh. Mohd. Sadiq Poswal, Social & RTI Activist on e-mail ([forestencroachments@gmail.com](mailto:forestencroachments@gmail.com)) created and reflected on the web page of committee constituted vide Govt. order No: 876-JK(GAD) of 2020 dated 19.9.2020 pursuant to the Hon'ble Court directions dated 03.09.2020 in PIL No: 25/2017 titled Animal Value Environment (SAVE) vs. State of J&K & Ors. regarding encroachment of forest land under survey No's 349, 351, 352, 354, 355, 356 etc. of village Sunjwan of South Jammu.

In this connection, I am directed to advise you to take immediate necessary action under relevant provisions of Indian Forest Act, 1927 and as per the directions of the Hon'ble Court as mentioned above in time bound manner. I am here with a complaint against then revenue and forest officials who help to grab State/ Forest/ Chapri land on references of mutation No.581 and 716 on which huge chunk of state/Forest land under survey No's.349, 351, 352 ,354, 355 , 356 etc. of village Sunjwan of South Jammu grabbed and sold illegally and fraudulently with the help of then revenue and forest officials who keep mum on encroachment of huge chunk of state land by tempering revenue records..

It is pertinent to mention to mention here that more khasra numbers created like 2219/353, 2218/354 etc. on behest of actually only one khasra which was 2218/353 of village Sunjwan from which Excess Fard issued by tempering of revenue records. Copy of tempering khasra number's along with others enclosed here with for further details.

So, kindly look matter urgent and order to hold enquiry to ascertain facts of complaints and thereafter retrieve all encroached state/ forest/ Chapri land under above given khasra numbers among it take strict action against concern officials and beneficiaries who grab state land by tempering of revenue records to meant money by this and that ways which lead to huge loss of exchequer of UT of J&K.
