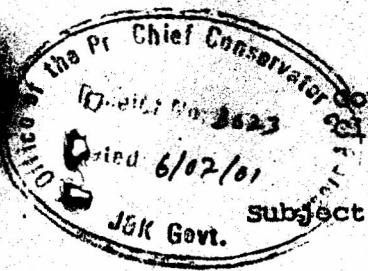

Subject: Diversion of Forest Land for widening/Up-gradation of Ramban-Gool road (Dharam Kund to Gool) 22-52 km by 52 RCC GREF.

Ref : Letter No: PCCF/MFP/L-J/177/2219-24 dated 13.12.2000 from Principal Chief Conservator of Forests.

Sanction is accorded to the transfer of Forest Land measuring 28.6 ha of forest land falling in compts.No:30,32, 33, 35a, 35b, 38, 39, 43 & 45 of Mahore Forest Division in Udhampur Distt. for widening/upgradation of Ramban Gool Road (Dharam Kund to Gool) 22-52 Km by 52 RCC GREF on the following terms and conditions:-

- 1/That the user agency will pay Rs.30,79,561/- as compensation for 706 trees of different species calculated @ two times of the standard rate of 1992.
- 2/That the user agency will pay Rs.6,322 lacs towards compensatory afforestation on degraded Forest land over double the forest area diverted.
- 3/That the user agency will pay an amount of Rs.83000/- towards renovation of fencing of the closures involved in the widening of the road.
- 4/That the cost of the land as would be assessed by the Revenue Deptt. shall be recovered from the user agency.
- 5/That the proprietary status of Forest land shall remain un-changed.
- 6/That any damage of trees done by the User agency will be charged @ ten times of the standard rate of 1992 as penalty.
- 7/That the indenting/user agency will construct complete retaining/breast walls on both sides of the road and take other necessary steps, so as to minimize soil erosion/land slips.
- 8/That the trees coming on the alignment shall be marked for extraction by SFC.
- 9/That the amount received shall be utilized by Forest Deptt, as provided in SRO 203 dated 13.4.2000.

The proposal stands cleared/approved by the Advisory committee in its 20th meeting held on 22nd March 2001.
