GOVT. ORDER NO. 194 FST of 2002

Sanction is hereby accorded to the transfer of
Forest land measuring 13.65 Ha passing through
compartment No. 1/K, 7/K, 16 to 20/K and 27/K of Anantnag
Forest Division in favour of Beacon authorities for widening
of existing road Anantnag to Sinthan - Kishtwar on the
following terms and conditions :-

1. That the proprietary status of Forest land shall remain un-changed.
2. That the Forest land shall be utilized only for the purpose for which it is diverted and shall not be transferred to any other agency without approval of the Forest Department.
3. That the user agency shall pay compensation of trees to the extent of Rs. 56.27 lacs @ two times the standard rate of 1992.
4. That the user agency shall pay compensation for land as a result of change in land use to be calculated equivalent to cost of land, which shall be assessed by Revenue authorities.
5. That the user agency shall also pay for compensatory afforestation to be carried over 28 Ha of degraded Forest land @ Rs. 10,000 per Ha.
6. That any damage of trees done by user agency shall be charged @ 10 times the standard rate of 1992 as penalty.
7. That the user agency shall construct retaining/breast walls on both sides of the road and take all other steps to minimize soil erosion/land slides.
8. That the extraction of trees shall be done by the State Forest Corporation.
9. That the user agency shall deposit the amount of Compensatory afforestation in the office of the Pr. Chief Conservator of Forests, J&K State in terms of SRO 203 dated 13-6-2000.
