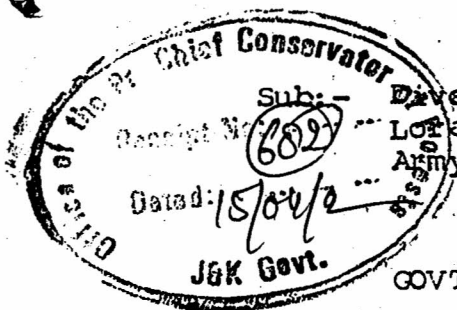

GOVT. ORDER No. 196 FST of 2002

D a t e d : 12 - 04 - 2002

Sanction is hereby accorded to the transfer of 5.0 Ha of Forest land passing through Compartment No. 121, 122, 125, 129, 107, 133/ Haveli of Poonch Forest Division for construction of Loran-Dholewali Narian Operational Track by Army on the following terms and conditions :-

1. That the proprietary status of Forest land shall remain un-changed.
2. That the Forest land so diverted shall be utilized only for the purpose for which it has been diverted and shall not be transferred to any other agency without the approval of the forest Department.
3. That the Forest land so diverted shall not be mortgaged re-assigned, sub-leased by user agency in any manner what-so-ever to any other agency.
4. That the user agency shall pay compensation of land on account of change of land use which shall be equivalent to cost of land as assessed by Revenue authorities.
5. That the user agency shall pay Rs. 23,57,687.00 on account of compensation of trees which is two times the standard rate of 1992.
6. That the gency shall pay Rs. 1.00 lac on account of compensatory afforestation over 10 Ha of degraded Forests.
7. That any damage done by the user agency or its employees and contractors or people employed by them shall be charged from the user agency @ 10 times the standard rate of 1992 as penalty.
8. That the extraction of trees shall be carried out by SFC on the basis of marking list duly approved by Conservator of Forests, Working Plan and Research Circle.

9. That the user agency shall construct retaining Walls/Breast Walls wherever necessary and take all other steps to minimize Soil erosion/land slips.
10. That the Forest land so diverted shall return to the Forest Department when it is not required by the user agency with out any cost.

The proposal stands cleared/approved by the Advisory Committee in its 21st meeting held under the Chairmanship of Chief Secretary on 31-01-2002.
