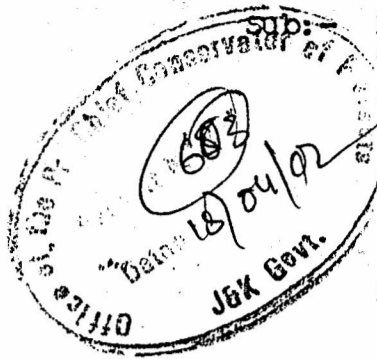

sub: Diversion of 5.6 Ha of Forest area for construction of Gran-Tote road by Public Works Department (R&B) in Reasi Forest Division of Udhampur District.

GOVT. ORDER No. 197 FST of 2002

D a t e d: 12 - 04 - 2002

Sanction is hereby accorded to the transfer of 5.6 Ha Forest Land (1-3 Kms) passing through compartment No. 35, 36, 37/ Reasi Range of Reasi Forest Division in favour of Public Works Department (R&B) for construction of Gran-Tote road on the following terms and conditions :-

1. That the proprietary status of Forest land shall remain un-changed.
2. That the Forest land so diverted shall be utilized only for the purpose for which it has been diverted and it shall not be mortgaged re-assigned, sub-leased to any other agency.
3. That the user agency shall pay compensation of land on account of change of land use which shall be equivalent to cost of land as assessed by the Revenue authorities.
4. That the user agency shall pay Rs. 6,92,760.00 on account of compensation of trees @ double the standard rate of 1992.
5. That the user agency shall pay Rs. 2,76,200.00 on account of compensatory afforestation over degraded Forest land twice in extent of forest land being diverted.
6. That any damage done to the forest by the user agency, its employees, contractors or people employed by them shall be charged from the user agency @ 10 times the standard rate of 1992 as penalty.
7. That the user agency will construct retaining/Breast walls on both sides of the road and will take all necessary steps to minimize soil erosion/land slips.
8. That the trees proposal to be felled will be handed over to SFC.

9. That the Forest land so diverted shall return to the Forest Department when it is not required by the user agency without any cost.
10. That the amount received shall be utilized by Forest Department as provided in SRO 203 dated 13-04-2000.

The proposal stands cleared/approved by the Advisory Committee in its 21st meeting held under the Chairmanship of Chief Secretary on 31-01-2002.
