Sub:- Diversion of 3.35 Ha. of Forest land for construction of Naska - Balot Army road by GREF in Bhaderwah Forest Division of Doda District.

GOVT. ORDER NO. 208 FST of 2002

D a t e d : 16 - 04 - 2002

Sanction is hereby accorded to the transfer of Forest Land measuring 3.35 Ha for construction of Naska Balot Army road by GREF passing through compartment No. 3/Wand 0/W in Neru Range of Bhaderwah Forest Division of Doda District on the following terms and conditions :-

1. That the proprietary status of Forest land shall remain un-changed.
2. That the land so diverted shall be utilized only for the purposes for which it has been diverted and it shall not be mortgaged, re-assigned or sub-leased by user agency in any manner whatsoever to any other agency.
3. That the user agency shall pay Rs. 11,55,750.00 for compensation of land on account of change of land use which shall be equivalent to the cost of land assessed by collector land acquisition.
4. That the user agency shall pay, Rs. 40,75,526.00 on account of compensation of trees @ 2 times the standard rate of 1992.
5. That the user agency shall pay Rs. 1,95,000.00 for compensatory afforestation over degraded forest land twice in extent of Forest land being diverted.
6. That the extraction of trees shall be done by State Forest Corporation.
7. That ~~the~~ any damage done to the Forest by user agency, its employees, contractors or people employed by them shall be charged from the user agency @ 10 times the Standard rate of 1992.
8. That the user agency will construct complete retaining/breast walls on both sides of the road and take other necessary steps to minimize soil erosion/land slips.
