Sub: - Transfer of Forest Land for Non-Forestry purposes in favour of various departments/agencies.

Sanction is hereby accorded to the transfer of Forest land for non-forestry purposes in favour of the following Departments/agencies as per details/terms and conditions noted against each:-

1. DIVERSION OF FOREST LAND FOR CONSTRUCTION OF TOWERS 54-B AND 55-A ON 220 KV SARNA UDHAMPUR TRANSMISSION LINE.

Forest land measuring 0.89 Ha which is required by Chief Engineer System and Operations Wings Power Dev.

Department Jammu for construction of towers 54-B and

55-A on 220 KV Sarna Udhampur Transmission line on the following terms and conditions:-

- i) The Proprietary status of Forest Land shall remain unchanged.
- ii) The cost of land as assessed by the Revenue Authorities shall be payable by the user agency.

2. ACQUISITION OF LAND FOR CONSTRUCTION OF WATER RESERVIOUS AID LAYING OF PIPELINE IN DODA DISTRICT BY ARMY.

Forest land measuring 0.86 Ha which is required by army in CO 32/Jai of Bhaderwah Forest Division for construction of Water Reservious and laying of pipeline on the following terms and conditions:-

- i). The proprietary status of Forest land shall remain un-changed.
- ii) The Forest land so diverted shall be utilized only for the purpose for which it has been diverted and shall not be transferred to any other agency without the approval of the Forest Department.
- iii) The Forest land so diverted shall not be mortgaged, reassigned, sub-leased by user agency in any manner what so-ever to any other agency.
  - iv) The user agency shall pay is. 2,57,250/- as compensation of land on account of change of land use which has been assessed as equivalent to cost of land by the Revenue authorities.

- v) Any damage done by the user agency or its employees and contractors or people employed by them shall be charged from the user agency @ 10 times the standard rate of 1992 as penalty.
- vi) The Forest land so diverted shall return to the Forest deptt. when it is not required by the user agency without any cost.
- vii) The User agency shall take all necessary steps to minimize soil erosion during the construction of Water Reservious and laying of pipeline.



3. CONSTRUCTION OF EMS FLATS FOR REHABILITATION OF SAFAIWALLAS AT MAIGIDOOM SAHIB SHRINE BACHI DARWAZA AT HARI PARBAT.

Folest land measuring 13 kanals and 16 marlas which is required by Administrator Srinagar Municipality for construction of EWS Flats for Rehabilitation of Safai Wallas at Makhdoom Sabib Shrine Bachidarwaza at Hari Parbat Srinagar on the Following terms and conditions:-

- i) The user agencines shall pay compensation on account of trees 0 2 times the standard rate of 1992.
- ii) Iny damage done by the user agency or its employees and contractors or people employed by them shall be charged from the user agencies @ 10 times the standard rate of 1992 as penalty.
- iii) The compensation of land, if any, will be paid by the Housing and Urban Dev. Department out of their own funds.
