GOVERNMENT ORDER NO. 323 -FST OF 2002  
D A T E D : 15 07.2002

Sanction is accorded to the diversion of 4.5 hac. Forest Land for construction of 132 KV Burn Janipur Transmission Line in compartment NO. 3-4/P in Jammu Forest Division on the following conditions:-

1. That the proprietary status of Forest land shall remain un-changed.
2. The land so diverted shall be utilized only for the purposes for which it has been diverted and it shall not be mortgaged re-assigned or sub-leased by user agency in any manner what-so-ever to any other agency.
3. The user agency shall pay for compensation of land as would be assessed by Revenue Department.
4. The user agency shall pay Rs. 12,000/- on account of compensation for trees at the rate of two times the standard rate applicable in 1992.
5. The user agency shall pay Rs. 90,000/- for compensatory afforestation over degraded forest land i.e. twice the forest land being diverted.
6. The maximum width of right of way shall be 27 Mts.
7. The extraction of trees shall be done departmentally.
8. Any damage done to the Forest by User Agency, its employees, contractors or people employed by them shall be charged from the User Agency @ ten times the standard rate of 1992.

The proposal stands cleared/approved by the Advisory Committee in its 21st meeting held under the Chairmanship of Chief Secretary on 31.01.2002.
