Subject:- Diversion of 3.36 hectares of Forest Land for Construction of Chiralla Link Road (5-9 kms) through Compartment 19, 24, & 26/ Chirralla in Bhaderwah Forest Division in Doda District.

D A T E D : 01-12-2002

Sanction is hereby accorded to the transfer of Forest Land measuring 3.36 hectares in Compartments NO. 19, 24, and 26/Chiralla of Bhaderwah Forest Division in Doda District for construction of Chiralla Link road (5-9 Kms) by Public Works Department on the following terms and conditions:-

1. That the proprietary status of Forest Land shall remain unchanged.
2. That the Forest land shall be utilized only for the purpose for which it is diverted and shall not be transferred to any other agency without approval of the Forest Department.
3. That the Forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what-so-ever to any other agency.
4. That the user agency shall pay Rs. 11,90,000/- as compensation of land as result of change in land use as assessed by Revenue authorities.
5. That the user agency shall pay compensation of trees to the extent of Rs. 6,08,501/- @ two times the standard rate of 1992.
6. That the user agency shall pay Rs. 1,56,752/- on account of compensatory afforestation over 07 hectares of degraded Forest Land.
7. That any damage of trees done by the user agency shall be charged @ ten times of the standard rate of 1992 as penalty.

8. That the extraction of trees shall be done by the state Forest Corporation on the basis of marking list approved by the Conservator of Forests, working Plan and Research Circle.
9. That the user agency shall construct retaining wall/breast wall on both side of the road and take other necessary steps so as to minimize soil erosion/land slides.
10. That the Forest land so diverted shall return to Forest Department when it is no longer required by the user agency without any cost.

The proposal stands cleared/approved by the Advisory Committee in its 22nd meeting held under the Chairmanship of Chief Secretary on 16.08.2002.
