Sanction is hereby accorded to the transfer of forest land measuring 37.515 Ha.falling in Comptt's NO. 57.53,61,62, 70.72,73 of Gandri Range in Batote Forest Division of Doda District in favour of Sawalkote Hydel Project Division P ower Development Corporation for construction of the following roads in Doda District on the following terms and conditions:

- a) External access road and link road a sight bank Portal.
- b) Access track from Dhamkund to Tanjar.
- The preprietary status of forest land shall remain unchanged.
- The forest land so diverted shall be utilized only for the purpose for which it has been diverted and it shall not be transferred to any other agency without approval of Forest Department.
- The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
 - The user agency shall pay for compensation of land on account of change of land use which shall be equivalent to cost of land as assessed by competent Revenue authorities.
 - The user agency shall pay an amount of Rs. 89,52,716 as compensation of trees to be felled @ two times standard rate of 1992.
 - The user agency will construct complete retaining/ breast walls on the both sides of the road and take other necessary steps, so as to minimize soil erosion/ land slips.
 - The user agency shall pay Rs. 15,29,888/- on account of compensatory afforestation to be carried over 76 Ha.degraded forest land.

- The extraction of trees shall be carried out by State Forest Corporation on the basis of marking list approved by Conservator of Forests, Working Plan and Research Circle.
- Any damage done to forest by user agency or its employees, centractors or people employeed by them shall be charged from the user agency at ten times the standard rate of 1992.
- The user agency shall deposit the amount of compensatory afforestation in the effice of the 10. Principal Chief Conservator of Forests, J&K Govt. as per provisions of SRO 203, dated 13.06.2000.
- 11. The forest land so diverted shall return to the Forest Department When it is not required by the User agency without any costs.
