Sanction is hereby accorded to the transfer of forest land measuring 3.2 Ha.falling in Comptt. NO. 4,5/Th of Reasi Forest Division for construction of Narloo-Tuli-Banna road (Kms 1-9) (Phase-I upto village Bagansal) by PWD (R&B) Reasi in District Udhampur on the following terms and conditions:

- 1. The proprietary status of forest land shall remain unchanged.
- 2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
- 3. The forest land so diverted shall not be mortgaged, assigned or sub-leased by the user agency to any other agency.
- 4. The user agency shall pay compensation of land on account of change of land use which shall be equivalent to cost of land as assessed by Revenue authorities.
- 5. The user agency shall pay Rs. 3,27,714/- on account of compensation of 837 trees at two times the standard rate of 1992.
- 6. The user agency shall pay Rs. 1,42,728/- on account of compensatory afforestation over 6.5 Ha of degraded forest land.
- 7. The extraction of trees shall be carried out departmentally/SFC on the basis of marking list approved by Conservator of Forests, Working Plan and Research Circle.
- 8. The user agency shall construct retaining/breast walls on the both sides of the road and will take all necessary steps to minimize soil erosion/land slides.

- Any damage done to the forest by the user agency, its employees, contractors, or people employed by them shall be charged from the user agency @ ten times the standard rate of 1992 as penalty.
- 18. The forest land so diverted shall return to the forest department when it is not required by the user agency without any costs.
