Sanction is accorded to the diversion of forest land measuring 19.85 Ha of forest area falling in Comptt. NOs 21 to 23/ Reasi, 25 to 28/Reasi and 39/Reasi for construction of approach road from Mattal Galla to Bakkal in Reasi Forest Division by Northern Railways on the following terms and conditions:

- The proprietary status of the forest land shall remain unchanged.
- 2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
- 3. The forest land so diverted shall not be mortgaged.

 re-assigned or sub-leased by user agency in any menner
 what-so-ever to any other agency.
 - The user agency shall pay Rs. 9.52,500/- towards compensation of land on account of change of land use which is equivalent to the cost of land as already assessed by the Revenue Authorities.
- 5. The user agency shall pay Rs. \$2, 55,27,140/- towards compensation of 3473 trees of different species and dia-classes @ two times of standard rate of 1992.
- 6. The user agency shall pay Rs. 5,86,921/- towards compensation afforestation to be carried over 38.10 Ha. of degraded forest land.
- 7. The user agency shall construct complete retaining/
 breast walls on the both sides of the road and take
 other necessary steps, so as to minimize soil erosion/
 land slides. In this regard, the user agency shall seek
 technical guidance from Director, Soil Conservation
 Department, J&K &r Govt.
- by SFC/Forest Department on the basis of marking list duly approved by Conservator of Forests, Working Plan and Research Circle.

- 9. Any damage done to the forest by the user agency or its employees, contractors or people employed by them shall be charged from the user agency @ ten times the standard rate of 1992 as penalty.
- 10. The forest land so diverted shall return to the Forest Department, when it is no longer required by the user agency without any cost.
- 11. The user agency shall deposit the amount of compensation afforestation in the office of Principal Chief Conservator of Forests, J&K Govt. as per SRO-203 dated 13.04.2009. The compensation of the trees felled and the compensation for any damage shall be deposited with the DFO Reasi.

The proposal stands cleared/approved by the Advisory Committee in its 26th Meeting held under the Chairmanship of Chief Secretary on 83.87.2004.
