Subject:- Diversion of Forest Land for Construction of Approach road from Village Gran to Portal-I of Tunnel No.5 at Village Trenth by Northern Railways.

GOVERNMENT ORDER NO. 342 -FST of 2004

D A T E : 05 -08- 2004

Sanction is hereby accorded to the transfer of forest land measuring 18.48 Kanals of forest area falling in Comptt. No.35/Reasi of Reasi Forest Division for construction of approach road from village Gran to Portal-I of Tunnel-No.5 at Village Trenth by Northern Railways on the following terms and conditions:

1. The proprietary status of the forest land shall remain unchanged.
2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what-so-ever to any other agency.
4. The user agency shall pay Rs. 92,400/- on account of compensation of land on a/c of change of land use which is equivalent to the cost of land as already assessed by the Revenue Authorities.
5. The user agency shall pay Rs. 15,360.50 towards compensation of 28 number of trees of different species and dia classes @ two times of the standard rate of 1992.
6. The user agency shall pay Rs. 69,899/- towards compensatory Afforestation scheme to be carried over 1.9 Ha. degraded forest land.
7. The user agency shall construct complete retaining/breast walls on both sides of the road and take other necessary steps, so as to minimize soil erosion/land slides. In this regard, the user agency shall seek technical guidance from Director, Soil Conservation Deptt., J&K Govt.
8. The extraction of trees shall be done by SFC/Forest Deptt. on the basis of marking list duly approved by the Conservator of Forests, Working Plan Circle.
9. Any damage done to the forest by the user agency or its employees, contractors or people employed by them shall be charged from the user agency @ ten times the standard rate of 1992 as penalty.

10. The forest land so diverted shall return to the Forest Deptt. when it is no longer required by the user agency without any cost.
11. The user agency shall deposit the amount of compensatory Afforestation in the office of Principal Chief Conservator of Forests, J&K Govt. as per SRO 293 dated 13.04.2000. The compensation of the forest land diverted, compensation for the trees felled and the compensation for any damage shall be deposited with the DFO Reasi.

The proposal stands cleared/approved by the Advisory Committee in its 26th Meeting under the Chairmanship of Chief Secretary on 03.07.2004.
