Subject: Diversion of Forest Land for parking of Mobile Low Power Transmitter by Doordarshan P.G.F Jammu at Patnitop in Doda District.

Reference: Cabinet Decision No.179/Cir dated 07.10.2004.

Sanction is accorded to the transfer of forest land measuring 1 Kanal (500 M<sup>2</sup>) falling under Comptt. No.10b/Botate Forest Division for parking of Mobile Low Power Transmitter by Doordarshan P.G.F Jammu at Patnitop in Doda District on the following terms and conditions:-

1. Only pre-fabricated hut shall be erected without constructing any compound wall, but the area shall be properly fenced.
2. The proprietary status of forest land shall remain unchanged.
3. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
4. The forest land so diverted shall not be mortgaged, re-assigned or sub-leased by user agency in any manner what-so-ever to any other agency.
5. Any damage caused to the forest by the user agency or its employees and contractors or people employed by them shall be charged from user agency at the rate of ten times the standard rate of 1992.
6. The user agency shall construct retaining/breast walls whatever necessary to minimize soil erosion/land slides.
7. Officials of the Forest Department shall have the right to inspect the forest land so diverted whenever it is deemed necessary.
8. The forest land so diverted shall return to the Forest Department when it is not required by the user agency without any costs.

The proposal stands cleared/approved by the Advisory Committee in its 25<sup>th</sup> Meeting held on 09.02.2004, under the Chairmanship of the Chief Secretary.






