Sanction is accorded to diversion of forest land measuring 9 Kanals falling under Compartment Forest Office cum Residence Complex in Block Sopore Town, Range Sopore, Kamraj Forest Division for construction of Sewerage Treatment Plant (STP) of Sofi Mohammad Akbar Hospital at Sopore by Health Department on the following conditions.

- 1. The proprietary status of forest land shall remain unchanged.
- 2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.
- 3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
- 4. The User Agency shall pay the cost of land to the tune of Rs. 90,00,000/- as intimated by Conservator of Forests, North Circle, Sopore.
- 5. The User Agency shall be bound to pay an amount of Rs. 4,48,400/- (Rs. Four lacs forty-eight thousand four hundred only) on account of compensation of 130 number of Poplar trees of different dia-classes.
- 6. The User Agency shall pay the cost of infrastructure on the proposed land to the tune of Rs. 24,44,000/- (Rs. Twenty-four lacs forty-four thousand only).
- 7. The extraction of trees shall be done by the SFC/Forest Department on the basis of marking list approved by Conservator of Forests, Working Plan Circle.
- 8. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from the user agency at the rate of ten times the standard rate of 1992.
- 9. The forest land so diverted shall return to the Forest Department when it is no longer required by the User Agency without any cost.
- 10. The user agency shall also pay any other amount which will become payable as per orders of Hon'ble Supreme Court or Government/Forest Department, J&K...
- 11. The user agency shall submit an undertaking that in case of any upward revision of rates of Net Present Value, the user agency will pay the amount of differential Net Present Value
- 12. The user agency shall construct complete retaining/breast walls on both sides of the road/railway line/earth work/tunneling etc., and take other necessary steps, so as to minimize soil erosion/land slips. In this regard, the user agency shall seek technical guidance from Director, Soil Conservation Department, J&K.
- 13. The mode of payment of compensatory afforestation shall be according to Compensatory Afforestation Fund Management and Planning Authority (CAMPA) rules and shall be communicated lateron.
- 14. The possession of forest land diverted for non-forestry number under the orders of the
