

GOVERNMENT OF JAMMU AND KASHMIR IVIL SECRETARIAT: FOREST DE PARTMENT.

Subject: Diversion of 3.04 ha of Forest Land for construction of Railway track from Surukote Tunnel T14 P2 and Bridge No. 61 in Mahore Forest Division.

Reference:- Cabinet Decision No. 70/8 Dated 31.03.2007

Government Order No: 17-4 FST of 2007 D A T E D 09 .04.2007

Sanction is accorded to diversion of forest land measuring 3.04 Ha. falling under Compartment, No. 81/Ar in Block Deadha, Range Gool, Mahore Forest Division for construction of Railway track from Surukote Tunnel T14 P2 and Bridge No. 61 by Dy. CE/S&C-III, Northern Railway, Udhampur on the following terms and conditions:-

1. The proprietary status of forest land shall remain unchanged.

2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.

. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any

manner what so ever to any other agency.

4. The User Agency shall pay Net Present Value of the forest land to the tune of Rs. 22,80,000/. (Rs. Twenty-two lacs eighty thousand only) as calculated by the concerned DFO as per Hon'ble Supreme Court Order dated 30-10-2002 in I.A. No: 566 in Writ Petition (Civil) No: 202 of 1995 T.N.Godavarman Thirumalpad V/S Union of India.

5. The user agency shall pay Rs. 1,52,000/- (Rs. One lac fifty-two thousand only) on account of

compensatory afforestation to be carried out 6.08 ha.

6. The User Agency shall be bound to pay an amount of Rs. 3,09,675/- (Rs. Three lacs nine thousand six hundred & seventy-five only) on account of compensation of 165 number of trees of different species and dia-classes.

. The extraction of trees shall be done by the SFC/Forest Department on the basis of marking list

approved by Conservator of Forests, Working Plan Circle.

8. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from the user agency at the rate of ten times the standard rate of 1992.

 The forest land so diverted shall return to the Forest Department when it is no longer required by the User Agency without any cost.

10. The user agency shall construct complete retaining/breast walls on the both sides of the road/railway line/earth work/tunneling etc., and take other necessary steps, so as to minimize soil crosion/land slips. In this regard, the user agency shall seek technical guidance from Director, Soil Consequation Department, J&K.

11. The user agency shall also pay any other amount which will become payable as per orders of Hon'ble Supreme Court or Government/Forest Department, J&K.

12. The user agency shall submit an undertaking that in case of any upward revision of rates of Net Present Value, the user agency will pay the amount of differential Net Present Value.

13. The possession of Forest land diverted for non-forestry purpose under the orders of the competent authority, should not be handed over to the user agency till all payments due against Competent of trees, NPV/Compensation of land, Compensatory afforestation costs etc are not deposited with Chief Accounts Officer in the office of the PCCF. Before handing over the possession of the corest land it should be further ensured that there are no outstanding dues with the said User Agency in respect of the cases sanctioned in the past.

14. The user agency shall be responsible to get requisite clearance under any other relevant win vogue.

15. The user agency should clear the debris resulting from the construction work from forest hand or will be bound to pay additional compensation to be workout by the DFO (Territorial) concerned for the damage caused to the Forest land, tree/poles and regeneration.
