

Subject :- Diversion of 2.13 Ha of Forest Land at village Bakkal for dumping of Muck by Northern Railways (dumping yard 75/P2) in Reasi Forest Division.

Reference: Cabinet Decision No. 89/7 dated 20.05.2008.

GOVERNMENT ORDER NO. / 60 - FST OF 2008 DATED; - 05 - 2008

Sanction is accorded to diversion of forest land measuring 2.13 Ha falling under Compartment No. 21/Reasi, in Block Bhomag, Range Reasi, Reasi Forest Division for dumping of Muck (dumping yard 75/P2) by Northern Railways on the following terms and conditions:

The proprietary status of forest land shall remain unchanged.

The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.

The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user

agency in any manner what so ever to any other agency,

The User Agency shall pay Net Present Value of the forest land to the tune of Rs. 15.97,500/- (Rs. Fifteen lacs ninety-seven thousand five hundred only) as calculated by the concerned DFO as per Hon'ble Supreme Courf Order dated 30-10-2002 in I.A. No: 566 in Writ Petition (Civil) No: 202 of 1995 T.N. Godavarman Thirumalpad V/S Union of India.

The User Agency shall be bound to pay an amount of Rs. 23,330/- (Rs. Twentythree thousand three hundred & thirty only) on account of compensation of 8

number of trees/poles of different species and dia classes.

The User Agency shall pay Rs. 1,15,653/- (Rs. One lacs fifteen thousand six hundred & fifty-three only) on account of compensatory afforestation to be carried over 4.26 ha.

7. The user agency shall ensure that muck is deposited at suitable site and rammed properly using machines/ implements so that it does not get washed away und becomes part of the existing soil. This should be further consolidated by planting soil binding species.

8. The extraction of trees shall be done by the SFC/Forest Department on the basis of marking list approved by Conservator of Forests, Working Plan Circle and

administratively approved by the Chief Conservator of Forests.

9. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from the user agency at the rate of ten times the standard rate of 1992.

10. The forest land so diverted shall return to the Forest Department when it is no

longer required by the User Agency free of any encumbrances.

11. The user agency shall construct complete retaining/breast walls on the all sides of the dumping site and take other necessary steps, so as to minimize soil erosion/l and slips. In this regard, the user agency shall seek technical guidance from Director, Soil Conservation Department, J&K.

12. The user agency shall also pay any other amount which will become payable as per orders of Hon'ble Supreme Court or Government/Forest Department, J&K.

13. The user agency shall be responsible to get requisite clearance under any other relevant law in vogue.

- 14. The user agency shall submit an undertaking that in case of any upward revision of rates of Net Present Value, the user agency will pay the amount of differential N:t
- 15. The possession of Forest land diverted for non-forestry purpose under the orders of the competent authority, should not be handed over to the user agency till all payments due against Compensation of trees, NPV/Compensation of land, Compensatory afforestation costs etc are deposited with Chief Accounts Officer in the office of the PCCF. Before handing over the possession of the Forest land it should be further ensured that there are no outstanding dues with the said Us w Agency in respect of the cases sanctioned in the past.

The proposal stands cleared/approved by the Advisory Committee in its 41st meeting held under the Chairmanship of the Chief Secretary on 25th February, 2008.
