Subject :- Proposal for replacement of Old Water Supply pipelines from Sitlee to Manda, Sitlee to Lohar and Lohar to Janipur in Wildlife Sanctuary Ramnagar, Jammu.

GOVERNMENT ORDER NO. 235 - FST OF 2008
D A T E D ; 2 - 06 - 2008

Sanction is accorded to diversion of forest land measuring 1.1925 ha in Ramnagar Wildlife Sanctuary for replacement of old water supply pipe lines from Sitlee to Manda, Sitlee to Lohar and Lohar to Janipur by the Economic Reconstruction Agency (ERA) on the following terms and conditions imposed by Hon'ble Supreme Court while granting permission for the said project:

1. Adhere to no damage to vegetation or wildlife due to laying/replacement of water pipes.
2. The carriage of water pipes and other requisites shall be by manual means only.
3. No habitat destruction to be carried out.
4. Fragmentation to habitat shall not be allowed and corridors shall be provided for free movement of animals.
5. 5% of the project cost shall be kept in the project for wildlife conservation and management in the sanctuary and the funds shall be kept at the disposal of the Department of Wildlife Protection.
6. No construction of road to be allowed inside the sanctuary.
7. Environmental Impact Assessment study has to be got done by the User Agency forthwith.

In addition the user agency shall also pay net present value, compensatory afforestation and compensation of trees (if trees are available) as per the provisions of J&K Forest Conservation Act and orders of the Hon'ble Supreme Court of India.

The proposal stands cleared/ approved by the Advisory Committee in its 41st meeting held under the Chairmanship of the Chief Secretary on 5th March, 2008.
