## GOVERNMENT OF JAMMU AND KASHMIR CIVIL SECTT: FOREST DEPARTMENT.

Subject:-Diversion of 8.55 ha of Forest Land for construction of road from T01 Km.2<sup>nd</sup> (Lamberi) to Plassi Hill by PWD under PMGSY in Nowshera orest Division.

GOVERNMENT ORDER NO. 260 - FST OF 2008 D A T E D; 03 - 06 - 2008

Sanction is accorded to the diversion of forest land measuring 8.55 ha falling under Compartment No. 3/N, 5/N & 6/N, in Rajal Block, Lamberi Range, Nowshera Forest Division for construction of road from T01 Km.2<sup>nd</sup> (Lamberi) to Plassi Hill under PMGSY by PWD, on the following terms and conditions:

1. The proprietary status of forest land shall remain unchanged.

2. The forest land so diverted shall be utilized only for the purpose for which it has been diverted. It shall not be transferred to any other agency without approval of the Forest Department.

3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user

agency in any manner what so ever to any other agency.

The User Agency shall pay Net Present Value of the forest land to the tune of Rs. 72,84,600/- (Rs. Seventy-two lacs eighty-four thousand six hundred only) as calculated by the concerned DFO as per Hon'ble Supreme Court Order dated 30-10-2002 in I.A. No: 566 in Writ Petition (Civil) No: 202 of 1995 T.N. Godavarman Thirumalpad V/S Union of India.

The User Agency shall pay an amount of Rs. 9,90,582/- (Rs. Nine lacss ninety thousand five hundred eighty-two only) on account of compensation of 690 no. of trees/poles/saplings of different species and dia-classes (Trees/Poles=605, Saplings of 0-10 dia-class=85).

The User Agency shall pay Rs. 4,27,500/- (Rs. Four lacs twenty-seven thousand five hundred only) on account of Compensatory Afforestation to be carried over 17.10 ha of degraded forest area.

- 7. The extraction of trees shall be done by the SFC/Forest Department on the basis of markings technically sanctioned by Conservator of Forests, Working Plan Circle and administratively approved by the Chief Conservator of Forests, concerned.
- 8. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from the user agency at the rate of ten times the standard rate of 1992.
- 9. The forest land so diverted shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency.
- The user agency shall construct complete retaining/breast walls on the both sides of 10. the road/railway line/earth work/tunneling/Water Reservoir etc., and take other necessary steps, so as to minimize soil erosion/land slips. In this regard, the user agency snall seek technical guidance from Director, Soil Conservation Department,
- the user agency snatt also pay any other amount which will become payable as per 11. orders of Hon'ble Supreme Court or Government/Forest Department. J&K.
- 12. The user agency shall be responsible to get requisite clearance under any other relevant law in vogue.
- The user agency shall submit an undertaking that in case of any upward revision of 13. rates of Net Present Value, the user agency will nay the amount of differential Net
- The possession of Forest land diverted for non-forestry purpose under the orders of 14 the competent authority, should not be handed over to the user agency till all payments due against Compensation of trees. NPV/Compensation of land. Compensatory afforestation costs etc are deposited with Chief Accounts Officer in the office of the PCCF. Before handing over the possession of the Forest land it

should be further ensured that there are no outstanding dues with the said User Agency in respect of the cases sanctioned in the past.

The proposal stands cleared/ approved by the Advisory Committee in its 41st meeting held under the Chairmanship of the Chief Secretary on 5th, March 2008 (second supp.agenda item No. 41.42).
