Subject :- Proposal for accord of felling permission of trees standing in strip plantation along Srinagar-Baramulla Road required due to widening of road from HMT Morh to Narbal Morh (Km 6.750 to Km 14.200) in Urban Forestry Division.

GOVERNMENT ORDER NO. 30/ - FST OF 2008
D A T E D ; 09 - 07 - 2008

Sanction is accorded to felling of 1206 trees standing in strip plantation along Srinagar-Baramulla Road required for widening of road from HMT Morh to Narbal Morh (Km 6.750 to Km 14.200) in Urban Forestry Division by 53 RCC GREF on the following conditions:

1. The User Agency shall be bound to pay an amount of Rs. 5,20,541/- (Rs. Five lacs twenty thousand five hundred forty-one only) on account of compensation of 1206 number of Poplar & Willow trees/poles of different dia-classes.
2. The User Agency shall pay Rs. 2,64,000/- (Rs. Two lacs sixty-four thousand only) on account of compensatory afforestation to be carried over 10.56 ha.
3. The user agency shall pay an amount of Rs. 1,32,664/- on account of cost of fencing involved.
4. The extraction of trees shall be done by the SFC/Forest Department on the basis of marking list approved by Conservator of Forests, Working Plan Circle and administratively approved by Chief Conservator of Forests, Kashmir.
5. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from the user agency at the rate of ten times the standard rate of 1992.
6. The user agency shall also pay any other amount which will become payable as per orders of Hon'ble Supreme Court or Government/Forest Department, J&K. The user agency shall be responsible to get requisite clearance under any other relevant law in vogue.
8. The possession of Forest land diverted for non-forestry purpose under the orders of the competent authority, should not be handed over to the user agency till all payments due against Compensation of trees, NPV/Compensation of land, Compensatory afforestation costs etc are not deposited with Chief Accounts Officer in the office of the PCCF. Before handing over the possession of the Forest land it should be further ensured that there are no outstanding dues with the said User Agency in respect of the cases sanctioned in the past.
