Subject: Proposal for felling of 6 number of Deodar green trees from State land in connection with construction of road from Batkoot to Pushward under PMGSY in Lidder Forest Division.

GOVERNMENT ORDER NO. 356-FST OF 2008 D A T E D; /6-09-2008

Sanction is accorded for felling 6 Deodar green trees from State land in connection with the construction of the road from Batkoot to Pushward under PMGSY, in Block Batkoot, Range Pahalgam, Lidder Forest Division by the Executive Engineer, PMGSY Division, Anantnag, on the following terms and conditions:

- 1. The User Agency shall pay an amount of Rs. 2,18,040/- (Rs. Two lacs eighteen thousand & forty only) on account of compensation of 06 No. of Deodar green trees of different dia-clases.
- 2. The User Agency shall pay Rs. 1,25,000/- (Rs. One lac twenty-five thousand only) on account of compensatory afforestation to be carried over 5 ha area of degraded forest area.
- 3. The extraction of trees shall be done by the State Forest Corporation on the basis of markings technically sanctioned by Conservator of Forests, Working Plan Circle and administratively approved by the Chief Conservator of Forests, concerned.
- 4. Any damage done to the forest by the user agency or its employees and contractors or people employed by them shall be charged from the user agency at the rate of ten times the standard rate of 1992.
- 5. The user agency shall also pay any other amount which will become payable as per orders of Hon'ble Supreme Court or Government/Forest Department, J&K.
- The user agency shall be responsible to get requisite clearance under any other relevant law in vogue.
- 7. The possession of Forest land diverted for non-forestry purpose under the orders of the competent authority, should not be handed over to the user agency till all payments due against Compensation of trees, NPV/Compensation of land, Compensatory afforestation costs etc are deposited with Chief Accounts Officer in the office of the PCCF. Before handing over the possession of the Forest land it should be further ensured that there are no outstanding dues with the said User Agency in respect of the cases sanctioned in the past.
- 8. Work on forest land shall be allowed only after the amount deposited by the User Agency is credited in the official account of Chief Accounts Officer and information to this effect is communicated to the Divisional Forest Officer concerned by the Pr. Chief Conservator of Forests office.

The proposal stands cleared/ approved by the Advisory Committee in its 43rd meeting held under the Chairmanship of the Chief Secretary on 20th June, 2008 (Agenda Item No. 43.23).
