Subject:- Use of 6.27 Ha. of forest land for construction of road from Sangri Top to Rampora Rajpora under PMGSY in Kamraj Forest Division.

Government Order No. 469 FST of 2008  
D a t e d : 16-12-2008

Sanction is accorded to the use of forest land measuring 6.27 ha. falling under Compartment nos 29/K, 30/K, 33/K, 36/K & 37/K in Blocks Botingoo, Khenusa and Yamberziwari, Range Kandi, Kamraj Forest Division (Distt. Barmulla), for the construction of road from Sangri Top to Rampora Rajpora by PWD under PMGSY on the following terms and conditions:-

1. The proprietary status of forest land shall remain unchanged.
2. The forest land shall be utilized only for the purpose for which it has been indented.
3. The forest land shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
4. The User Agency shall pay the following amount :-
  - i. Net Present Value = Rs. 62,13,570/-
  - ii. Compensation of 226 Trees/Poles = Rs. 6,09,660/-
  - iii. Compensatory Afforestation = Rs. 3,13,500/-

**TOTAL = Rs. 71,36,730/-**
5. The extraction of trees/poles shall be done by the J&K State Forest Corporation on the basis of markings technically sanctioned by Conservator of Forests, Working Plan Circle and administratively approved by the Chief Conservator of Forests, concerned.
6. The User Agency shall construct Retaining/Breast walls and take all necessary steps to check soil erosion likely to occur due to construction of road. In this regard, the User Agency shall seek technical guidance from the Director, Soil Conservation Department, J&K.
7. Any damage done to the forest land/crop shall be charged @ 10 times the standard rate of 1992.
8. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency.

9. The User Agency shall be responsible to obtain requisite clearances under any other relevant law in vogue.
10. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the Office of Pr.Chief Conservator of Forests, J&K.
