Sanction is accorded to the use of forest land measuring 3.00 ha falling under Compartment nos 14/AC,17/AC & 9/AC in Block Chandanwari, Range Pahalgam, Lidder Forest Division (Distt.Anantnag), for the widening and upgradation of Pahalgam-Chandenwari road by PWD under PMGSY on the following terms and conditions:-

1. The proprietary status of forest land shall remain unchanged.

The forest land so allowed for use shall be utilized only for the purpose for which it has been indented. It shall not be transferred to any other agency without approval of the Forest Department.

3. The forest land so allowed for use shall not be mortgaged, reassigned or subleased by user agency in any manner what so ever to any other agency.

4. The User Agency shall pay the following amount :-

i. Net Present Value = Rs. 26,91,000

ii. Compensation of 90 Trees/Poles = Rs. 8,52,140

iii. Compensatory Afforestation = Rs. 1,50,000Total . = Rs. 36,93,140

5. The extraction of trees/poles shall be done by the J&K State Forest Corporation on the basis of markings technically sanctioned by the Conservator of Forests, Working Plan Circle and administratively approved by the Chief Conservator of Forests, concerned.

The User Agency shall construct retaining/breast walls and take all necessary steps to check soil erosion which may result due to widening of the road. In this regard, the User Agency shall seek technical guidance from the Director, Soil Conservation Department, J&K.

7. The User Agency shall not dump the debris on the forest land.

8. Any damage done to the forest land/crop shall be charged @ 10 times the standard rate of 1992.

9. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency.

10. The User Agency shall be responsible to obtain requisite clearances under any other law in vogue.

11. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the Office of Pr.Chief Conservator of Forests, J&K.
