Sanction is accorded to the felling of 105 trees/poles, road side plantation (67 trees/poles raised by Urban Forestry Division Jammu and 38 trees/poles raised by Social Forestry Division, Jammu) for four-laning of NH-1A at Kunjwani (Distt. Jammu) by National Highway Authority of India (NHAI) on the following terms and conditions:-

1. The User Agency shall pay the following amount :-
 - i. Compensation of 105 Trees/Poles = Rs. 1,32,700/- (UF Div. Rs.62748+
SF Div. Rs 69952)
 - ii. Compensatory Afforestation = Rs. 1,50,000/-
 - TOTAL = Rs. 2,82,700/-**
2. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue.
3. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the Office of Pr.Chief Conservator of Forests, J&K.

The proposal stands cleared by the Advisory Committee in its 44th meeting held under the Chairmanship of the Chief Secretary on 28.11.2008 (Agenda item No.44.19).


