

**GOVERNMENT OF JAMMU AND KASHMIR

Subject:- Use of 0.645 hectare of forest land for construction of Hutments, Sheds, Dormitories, Restaurant, Parking place and Herbal Garden at Jai by Bhaderwah Development Authority in Bhaderwah Forest Division.

Government Order No. 476 FST of 2008

Sanction is accorded to the use of forest land measuring 0.645 hectare falling under Compartment Nos. 21c/Jai, 22b/Jai, 31/Jai and 32a/Jai Block Jai, Range Chiralla, Bhaderwah Forest Division (Distt. Doda) for construction of Hutments, Sheds, Dormitories, Restaurant, Parking place and Herbal Garden on the following terms and conditions:-

1. The proprietary and legal status of forest land shall remain unchanged.
2. The forest land shall be utilized only for the purpose for which it has been indented.
3. The forest land shall not be mortgaged, reassigned leased or sub-leased by user agency in any manner what so ever to any other agency.
4. The User Agency shall pay Rs. 6,39,195/- as Net Present Value.
5. The User Agency shall not take up any other infrastructural development activity on forest land other than that allowed for use.
6. The User Agency shall take all necessary steps to check soil erosion which may occur due to proposed construction of infrastructural development works.
7. Any damage done to the forest land/crop shall be charged @ 10 times the standard rate of 1992.
8. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and is rehabilitated properly.
9. The User Agency shall be responsible to obtaining requisite clearances under any other law in vogue.
10. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the Office of Pr.Chief Conservator of Forests, J&K.

The proposal stands cleared by the Advisory Committee in its 44th meeting held under the Chairmanship of the Chief Secretary on 28.11.2008 (Agenda item No.44.18).


