

**GOVERNMENT OF JAMMU AND KASHMIR

**Subject:-** Use of 0.63 hectare of forest land for muck disposal of Tunnel No. 34 (P1-P2) in Comptt. No. 53/Ar by Northern Railway in Mahore Forest Division.

**Reference:** State Administrative Council decision No. 98/8/2008 dated 11.12.2008.

Sanction is accorded to the use of forest land measuring 0.63 hectare falling under compartment No.53/Ar, Block Dhedha, Range Gool, Mahore Forest Division (Distt. Ramban) for muck disposal of Tunnel No. 34 (P1-P2) in Comptt. No. 53/Ar by Northern Railway on the following terms and conditions:-

1. The proprietary and legal status of forest land shall remain unchanged.
2. The forest land shall be utilized only for the purpose for which it has been indented.
3. The forest land shall not be mortgaged, reassigned leased or sub-leased by user agency in any manner what so ever to any other agency.
4. The User Agency shall pay Rs. 4,40,370/- towards Net Present Value.
5. The User Agency shall construct retaining/breast walls around the dumping site and ensure that muck dumped is rammed properly using machines/ implements so that it does not get washed away and is stabilized/rehabilitated properly. This should further be consolidated by planting soil binding vegetation (grass/shrubs etc).
6. Any damage done to the forest land/crop shall be charged @ 10 times the standard rate of 1992.
7. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and is rehabilitated.
8. The User Agency shall be responsible to obtaining requisite clearances under any other law in vogue.
9. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the Office of Pr.Chief Conservator of Forests, J&K.

The proposal stands cleared by the Advisory Committee in its 44<sup>th</sup> meeting held under the Chairmanship of the Chief Secretary on 28.11.2008 (Agenda item No.44.17).




