Sanction is accorded to the felling of 371 trees/poles raised by Social Forestry Department on state land (road side plantation) in connection with widening of Kalibari-Kathua-Hatli Morh road (Distt. Kathua) by the J&K Economic Reconstruction Agency (ERA) on the following terms and conditions:-

1. The User Agency shall pay Rs. 6,98,928/- as compensation of trees/poles.
2. The User Agency shall take necessary steps to check soil erosion likely to occur due to proposed widening of road.
3. The User Agency shall be responsible to obtain requisite clearances under any other law in vogue.
4. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the Office of Pr.Chief Conservator of Forests, J&K.

The proposal stands cleared by the Advisory Committee in its 44th meeting held under the Chairmanship of the Chief Secretary on 28.11.2008 (Agenda item No.44.10).
