1. The proprietary status of forest land shall remain unchanged.

- The forest land so allowed for use shall be utilized only for the purpose for which it has been indented. It shall not be transferred to any other agency without approval of the Forest Department.
- The forest land so allowed for use shall not be mortgaged, reassigned or subleased by user agency in any manner what so ever to any other agency.
- 4. The User Agency shall pay the Net Present Value of Rs. 73,745/- as per Hon'ble Supreme Court Order dated 28-03-2008 and dated 09-05-2008.
- 5. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency.
- 6. The User Agency shall be responsible to obtain requisite clearances under any other law in vogue.
- 7. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the Office of Pr Chief Conservator of Forests, J&K.

The proposal stands cleared by the Advisory Committee in its 44th meeting held under the Chairmanship of the Chief Secretary on 28.11.2008 (Agenda item No.44.04).
