CORRIGENDUM OF GOVERNMENT ORDER NO. 250 – FST OF 2006 D A T E D ; 18 - 06 - 2006

As approved by the Forest Advisory Committee in its 41<sup>st</sup> meeting held under the Chairmanship of the Chief Secretary on 5<sup>th</sup>, March 2008, Please read "0.2 ha (4 kanals)" instead of "0.45 ha (9 kanals)" in the Government order No. 250-FST of 2006 and 18.05.2006.

## Further condition No. 4 of the aforesaid Govt. order is recast as under:

"The User Agency shall pay Net present Value of the forest land as would be assessed by the concerned DFO as per Hon'ble Supreme Court order dated 30.10.2002 in I.A No. 566 in Writ Petition (Civil) No. 202 of 1995 T.N. Godavarman Thirumalpad V/S UInion of India. However the cost of land as assessed by the Revenue Department is Rs. 4,00,000/- @ Rs. 2,00,000/ per kanal"
