- 1. The proprietary status of forest land shall remain unchanged.
- The forest land shall be utilized only for the purpose for which it has been indented.
- 3. The forest land shall not be mortgaged, reassigned or sub-leased by user agency in any manner what so ever to any other agency.
- The User Agency shall pay the following amount:-

i. Net Present Value

= Rs. 15,886

ii. Compensation of 5 T/P/S

= Rs. 4,293Rs. 20,179

iii. Rent per month = Rs. 9000/-

- The extraction of trees/poles will be done by J&K State Forest Corporation after the markings are technically sanctioned by the Conservator of Forests, Working Plan Circle and administratively approved by the Chief Conservator of Forests, concerned.
- 6. An increase of 25% in Rent shall be charged after every 3 years.
- 7. The User Agency shall furnish Bank Guarantee of a Nationalized Bank for an amount equivalent to rent of 3 years.
- 8. No permanent construction of the building shall be allowed at the proposed site.
- 9. The User Agency shall not dump the debris on forest land.
- 10. The User Agency shall take all necessary steps to check soil erosion which may result due to excavation of the foundation of the tower.
- 11. Any damage done to the forest land/crop shall be charged @ 10 times the standard rate of 1992.
- 12. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and it is rehabilitated properly by the User Agency.
- 13. The User Agency shall be responsible for obtaining requisite clearances under any other law in
