Subject:- Amendment in the relevant condition of sanction order issued for use of forest land in favour of Power Development Corporation for IPP (Independent Power Producer) project in accordance with State Hydel Policy.

Sanction is accorded to the amendment of Govt. order No. 145-FST of 2008 dated 26.5.2008, as under:- 185.FST

The condition No. 3 of the said order,

"3. The forest land so diverted shall not be mortgaged, reassigned or sub-leased by user agency in any manner whatsoever to any other agency."

is substituted as under:-

"3. The user agency i.e; Power Development Corporation shall not lease the forest land so allowed for use to the IPP (Independent Power Producer). However, the competent authority of the Government may lease the forest land in favour of IPP strictly in accordance with the terms and conditions of the State Hydel Policy."

The proposal was discussed by the Advisory Committee in its 45th meeting held on 9.3.2009 and 46th meeting held on 8.5.2009, and was accordingly cleared.


