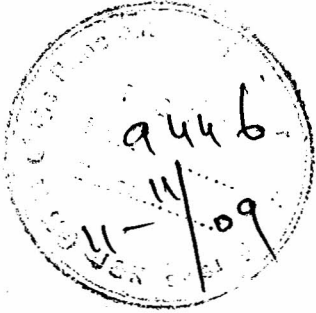

Sanction is accorded to felling of 1015 trees/poles of Soil Conservation Department involved in Widening of Road from Kalu Chak to Purmandal by PWD (R&B) Division-IV Jammu; *subject to following conditions:-*

- i. The user agency shall pay Rs. 2,25,302/- out of which Rs. 81,922/- as compensation for felling of 1015 trees/poles and Rs. 1,43,380/- for damage to the fencing, to forest department.
- ii. Extraction of 1015 trees/poles coming in the said land shall be done by the State Forest Corporation after the markings are technically sanctioned by the Conservator of Forests and Administratively approved by the Chief Conservator of Forests concerned
- iii. The user Agency shall construct retaining/breast walls and take all necessary steps to check Soil erosion which may result due to proposed construction of the Road. The user agency shall seek technical guidance in this respect from the Director, J&K Soil Conservation Department.
- iv. The user agency shall be responsible for obtaining requisite clearances under any other Law in vogue.
