1. The User Agency shall pay the following amount.

i.	Comp. of Poles / Saplings	=Rs. 34,960/-

- 2. The extraction of poles/ saplings shall be done by the State Forest Department (SFD)/ State Forest Corporation (SFC) on the basis of markings administratively approved by the Director, Social Forestry Department, J&K. The cost of extraction and transportation shall be borne by the User Agency
- 3. Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from User Agency @ Ten times the standard rates of 1992.
- 4. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue.
- 5. The amount on account of various Heads to be paid by the user agency as detailed above shall be deposited with the Chief Accounts Officer in the Office of the Principal Chief Conservator of Forests, J&K.

6. SFD may consult the local people if they would like to use saplings/ wildlings of selected species coming in the alignment for plantation in their own lands. In case of a positive response, the saplings may be supplied through JFM Committee/ Village Forest Committee with no cost on the SFD.
