Sanction is hereby accorded to use of 0.12 Ha. of Forest Land for erection of Communication Towers at Baltal-I, Baltal-II, Domail, Bradimarag Holy Cave and Panjtarni Points in Comptt.63a/Sindh by SDE (Group) BSNL in Sindh Forest Division subject to the following terms and conditions:

- 1 *The proprietary and legal status of forest land shall remain unchanged.*
- 2 *The forest land shall be utilized only for the purpose for which it has been indented.*
- 3 *The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.*
- 4 *The User Agency shall pay the following amount after the forest clearance is accorded: -*

i.	Net Present Value	Rs. 83,880/-
	TOTAL	Rs. 83,880/-

- 5 No permanent construction of the building shall be allowed at the proposed site.
- 6 The user Agency shall not dump the debris on forest land.
- 7 The User Agency shall take necessary steps to check soil erosion likely to occur during excavation for the foundation of the tower.
- 8 Any damage done to the forest land/crop shall be charged @ 10 times the standard rate of 1992.
- 9 Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from User Agency @ 10 times the standard rate of 1992.

10 The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue.

11 The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the Office of Pr. Chief Conservator of Forests, J&K.
