Sanction is hereby accorded to use of 0.0275 hac. of Forest Land from Compartment No. 57/\$ of Ramnagar Forest Division in District Udhampur, for construction of 10,000 Gallon Capacity Sump Tank for WSS Pinger by PHE Department on following terms and conditions: -

- I. The Proprietary status of Forest land shall remain unchanged.
- II. The Forest land shall be utilized only for the purpose for which it has been indented.
- III. The Forest land in question shall not be mortgaged, reassigned or sub-leased by user agency in any manner whatsoever to any other agency.
- IV. The user agency shall pay the following amount: -

i .	Net Present Value	= Rs. 18,067/-

- V. The user Agency shall not dump the debris on the Forest land.
- VI. The Forest land so allowed for use shall return to the Forest Department free of any encumbrances when it no longer required by the user agency and after it is rehabilitated properly by the user agency.

- VII. The user agency shall be responsible for obtaining requisite clearances under any other Law in vogue
- VIII. The possession of the Forest land diverted for non forestry purpose above shall not be handed over to the user agency till all payments due on account of NPV/compensation of land, compensatory afforestation costs, are deposited with the Chief Accounts Officer in the Office of the Principal Chief Conservator of Forests J&K. Before handing over the possession of the land in question it should further be ensured that there are no outstanding dues with the said user agency in respect of the cases sanctioned in the past.
